## YOUTH FIREFIGHTER CAMP

**Welcome to Limerick Fire Company's Youth Firefighter Camp. Due to the success of our camp, the deadline to register cannot be extended and attendance is limited.**

All registered cadets will receive one LFC Fireman's tee shirt and LFC baseball cap to wear as their 'daily uniform'. The hat and 'uniform shirt' must be worn every day because it identifies which group the cadet is assigned to for the week. If you are interested in purchasing extra camp shirts, they must be ordered at the time of registration-\$10 per shirt.

Why try *this* Camp? **You will:**

- ▶ Learn fire safety you thought you knew & then apply what you've learned
- ▶ Learn about the fire house, trucks (apparatus), and personnel
- ▶ Hands-on with various equipment
- ▶ Ladders-learn the how-to's
- ▶ Hoses-proper techniques to connect to the hydrant, flow water, roll up, etc.
- ▶ Extinguishers-the ABC's
- ▶ Rescue tools during simulated live demonstrations
- ▶ Fire gear-bunker pants, jacket, helmet, safety gloves & glasses all provided
- ▶ Watch & participate in several live demonstrations with the firefighters
- ▶ And so much more....

### Information

We require closed-toed shoes/sneakers every day. Open-toe shoes & flip flops are not permitted.

Camp will go on if there is rain or excessive heat. We will take necessary safety measures.

Each adult **MUST** walk their camper to the sign in station and sign the camper in with staff. No camper is allowed to sign themselves into camp. If someone other than the parent/parties on the registration form is picking up the camper, a note **MUST** be sent in at the time of morning drop off. This person must also show a valid photo ID when picking up.

Thank you for help keeping your child safe. We appreciate your understanding.

*It happens – you're running late.* We understand that sometimes extenuating circumstances prohibit a parent from picking up a child on time. However, we are also concerned with fairness to our volunteer firefighter staff. Please call Camp Coordinator Kara Shuler at 484-390-1838 immediately upon knowing of your delayed arrival.

## Rules

1. No one may leave camp early without permission. If you need to leave before 12 pm, written permission is required.
2. No alcohol, firecrackers, weapons, tobacco, or drugs are permitted in camp. Check medications with health personnel. Violators will be sent home without refund.
3. Cadets are not permitted in others' belongings.
4. Cadets will be charged for the cost of any physical facility and/or resource damage for which they are responsible.
5. Cadets are not permitted to have cell phones in camp. A phone is available for necessary calls.
6. Cadets shall follow all health and safety regulations.
7. Limerick Fire Company is not responsible for loss, theft, or damage of personal items brought to camp. Please leave valuable items at home.
8. Programs and activities offered by the Limerick Fire Company are available to all persons without regard to race, color, sex, disability, religion, age, veteran status, political beliefs, sexual orientation, national origin, and marital or family status.
